

## Social Media Giveaway Terms & Conditions

- For the purposes of these Terms and Conditions ("Terms"), "The Promoter" refers to ST Services Iberia SL a company incorporated in Spain with number B64767627 and registered address Torroella de Montgrí (Girona - 17257), Carretera de l'Estartit, numbers 143-145, building 7-8 and these Terms apply as between you and The Promoter.
- The Promoter and the influencer are collaborating together to promote this Competition. The influencer is Juliana Alvarez Curetti whose Instagram profile is: @viajandovivamos 'Influencer'.
- Each entrant shall enter the competition (the 'Competition') via Instagram by following The Influencers and The Promoters page, liking The Promoters or the Influencers Competition post and commenting on the specified post on either page. You have 7 (seven) days to respond to our request, if you do not respond within 7 (seven) days you have forfeited your right to the Prize and the Promoter shall choose a different winner.

The Promoter reserves the right in its sole discretion to ask for evidence to verify the name, identity and/or eligibility of an entrant at any time. - The Promoter's decision is final. However, any disputes shall be subject to the exclusive jurisdiction of the English courts. Only after you have tried to solve any dispute directly with the Promoter.
- The Competition and these Terms are exclusively governed by and construed in accordance with the laws of England.
